WELCOME

Mary Jones called the meeting to order at 9:02 a.m.

PREVIOUS MEETING MINUTES – 2/27/2019

Courtney Cross moved that the 2/27/2019 minutes be approved. Roxanne del Rio seconded the motion, and the minutes were approved.

CURRENT BUSINESS

DCHC: Systems Oriented; Mission and Focus; Goal Setting; Projects; Fundraising; Community Engagement and Education; Information and Data.

COMMITTEE/TASK FORCE ACTIONS

- Housing Priority List – CE Data Report – Katherine Gonzales
 - Katherine reviewed the HMIS Data Report, including the number of single and family households in need of either Diversion, Rapid Re-Housing, or Permanent Supportive Housing. The data was also presented to show monthly inflows and outflows.
 - The data was revised last month based on feedback from front door agencies. Many individuals were moved to the inactive list. Katherine stated that they are continually working to clean up data and develop processes so that we are tracking those in the system on a more frequent basis, especially those in the priority populations. Additionally, front door agencies are working to solve Diversion issues earlier in the process.

- Barriers Fund and Current Donations – Courtney Cross
 - Thirty-one households have been assisted with things such transportation vouchers, furniture, minor car repairs, drivers licenses, and other diversion efforts. These requests have totaled about \$13,500.
 - Financial Report
 - There is limited funding available for general client assistance. The bulk is reserved for landlord outreach assistance.
- PIT Count – Courtney Cross and Katherine Gonzales
 - This year's PIT Count took place on January 24, 2019.
 - The preliminary data from the Count has been reviewed. The Coalition will begin preparing a report on the data and planning its reveal to the community.

OTHER REPORTS

- CoC Representative – CoC Meeting – Stephanie Jerez-Rodriguez
 - The most recent CoC meeting was held on March 13, 2019. The main topic of discussion was Emergency Shelters, and included various panel discussions related to the topic.

- Denton County Homeless Leadership Team (HLT) – Mary Jones
 - There was no HLT meeting in March. The next HLT meeting will be held on April 11, 2019.
- 100-Day Challenge
 - The Challenge Committee will meet in April to start laying the foundation for the event. Feedback was gathered regarding what issues need to be discussed.
 - Due to grant funding timelines, the Committee will consider delaying the start of the Challenge until the beginning of 2020.
